ORDER

(Hearing on 16.11.2016)

UP State Load Dispatch Centre (UPSLDC) has filed petition no. 1217/2017 on 18.07.2017 praying the commission as follows:



- (1) To make necessary amendments in the UP Grid Code, 2007 in line with the Indian Electricity Grid code (fourth amendment) Regulation 2016 notified by the CERC on 6.4.2016 and in line with the detailed operating procedure prepared by the NLDC and mechanism for compensation for Station heat rate, auxiliary energy consumption etc. submitted by the RPCs and approved by Hon'ble CERC vide order dt 5.5.2017 which came into force w.e.f. 15.5.2017.
- (2) To specify technical minimum schedule of all generating stations (State generating stations, IPPs, Cogens etc) at 55% in line with Indian Electricity Grid code (fourth amendment) Regulation 2016 notified by the CERC on 6.4.2016 and in line with the detailed operating procedure prepared by the NLDC and mechanism for compensation for Station heat rate, auxiliary energy consumption etc. submitted by the RPCs and approved by Hon'ble CERC vide order dt 5.5.2017 which came into force w.e.f. 15.5.2017.
- 2. The counsel for UPSLDC, Sri Rahul Srivastava informed the Commission that Hon'ble CERC has notified the amendment in Indian Grid Code 2007 and the new Indian Electricity Grid Code (fourth amendment) Regulation 2016 has become effective w.e.f. 15.05.2017. He requested that as per the prayer in the petition Indian Electricity Grid code (fourth amendment) Regulation 2016 notified by the CERC vide order dt 6.4.2016 and in line with the detailed operating procedure prepared by the NLDC and mechanism for compensation for Station heat rate, auxiliary energy consumption etc. submitted by the RPCs and approved by Hon'ble CERC vide order dt 5.5.2017 which came into force w.e.f. 15.5.2017 may also be adopted by this Hon'ble Commission by making appropriate amendments in the UP Electricity Grid Code 2007.
- 3. Sri Deepak Raizada, SE (Planning), UPPCL appearing on behalf of UPPCL made a point that as per UP Electricity Grid Code 2007 no additional compensation for Station heat rate, auxiliary energy consumption is admissible to any generator on reducing the load of the generating plant. He stressed that adoption of National Electricity Grid Code 2016 in its present form will cast additional financial burden on the state distribution

companies that are already in a difficult financial position. He prayed that for Independent

Power Producers supplying power to UP Discoms, no change should be made in the UP-

Electricity Grid Code 2007. The Commission pointed out that in case of reduction of load

to technical minimum as specified in Electricity Grid Code 2016 the generators will have to

incur additional cost due to additional station heat rate, auxiliary energy consumption etc.

then how they will agree to the request of UPPCL. Sri Sumeet Notani appearing on behalf

of Rosa Power Company Ltd., requested that for their plant the Indian Electricity Grid

Code 2016 should be applicable. Some other representatives of Independent Power

Producers also raised similar issues.

4. The Commission allowed one-week time to Independent Power Producers to file

their written submission on this issue and decided to hold a public hearing.
