## **ORDER**

(DATE OF HEARING: 22.04.2025)

- 1. During the hearing, Ms. Shikha Ohri, Counsel for the petitioner (DIL), apprised the Commission that the petition filed by them before CERC, for approval of final capital cost of the De-NOx system, was listed on 28.04.2025. However, the final order is expected in June/July, 2025 as the pleadings are still incomplete.
- 2. The Commission observed that since the issue involved in the present case has a direct linkage with the matter pending before CERC, therefore, approval of final capital cost apportioned to NPCL could be conclusively ascertained only after CERC's order. The Commission directed the petitioner to submit certification / validation of NOx emission levels by CPCB as submitted by the petitioner vide its rejoinder dated 02.04.2025 and also to clarify regarding NOx emission values exceeding the prescribed limit of 450 mg/Nm3 during January 2024 and October 2024.

The matter is listed for next hearing on 22.07.2025.
