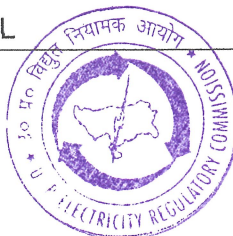

## ORDER

**(DATE OF HEARING: 15.05.2025)**

1. The Commission, vide its earlier Order dated 25.04.2025, granted two weeks' more time to UPPCL for filing requisite information. On 13.05.2025, UPPCL filed its submission.
2. During the hearing, Sh. Divyanshu Bhatt, Counsel of UPPCL submitted that they had filed the requisite information in compliance to the Commission's Order dated 11.04.2025, therefore, the Commission could reserve its order.
3. The Commission observed that UPPCL's response to the query seeking details of 'compliance status of bidding documents for the change in shareholding of project company' was missing. While it has been stated that post commissioning of the project, there had not been any change in shareholding pattern of Adani Solar Energy Four Pvt. Ltd., yet the details of name/shareholding pattern change from Kilaj Solar (Maharashtra) Pvt. Ltd. to Adani Solar Energy Four Pvt. Ltd. mapped against the relevant provisions of bidding documents along with correspondence/ details in this regard had not been placed on record of the Commission. Sh. Bhatt sought one week time to furnish the details on the Commission's observations.
4. After hearing the parties, the Commission allowed one week time to UPPCL to furnish its details as mentioned above at para 3 of this Order.
