(Date of Hearing 28.11.2014)

- 1. The Dwarikesh Sugar Industries Ltd filed a petition on date 05.09.2014 seeking review of the Commission's order dated 21.08.2014 passed in the petition no. 835 of 2012.
- Dwarikesh Sugar Industries Ltd filed application on 07.10.2014 for withdrawal of petition to exercise their right to appeal against above stated order in APTEL within 45 days (i.e. 09.10.2014) of impugned order and subsequently filed appeal in Hon'ble APTEL.
- 3. Hon'ble APTEL in its order dated 29.10.2014 directed UPERC to pass an order in the said review petition.
- 4. However, during the hearing it was submitted by respective counsels of petitioner as well as respondents that Hon'ble APTEL has directed the Commission to pass an order in the matter of withdrawal of petition.
