CALLING FOR NOMINATIONS FOR APPOINTMENT OF CHAIRMAN OF THE UTTAR PRADESH ELECTRICITY REGULATORY COMMISSION.

The Uttar Pradesh Electricity Regulatory Commission has been constituted under the provision of Regulatory Commission Act, 1998 with Chairman and two Members to regulate the electricity Industry in Uttar Pradesh to act in an efficient economic, safe and transparent manner. The appointment on the post of Chairman of the Commission has fallen Vacant on 01-09-2017. Accordingly, it is decided to call for nominations from suitable persons to fill up the Post of Chairman of the U.P. Electricity Regulatory Commission. The appointment would be made in accordance with the following requirements :-

- 1) The Chairperson of the State Commission shall be persons of ability, integrity and standing who have adequate knowledge of, and have shown capacity in, dealing with problem relating to engineering, finance, commerce, economics, law or management .
2. Interested candidates may send their representations with following details :
 - 1) Bio-data of proposed candidate containing the following details :-
 - a) Name
 - b) Age & Date of Birth
 - c) Position now held
 - d) Educational Qualification
 - e) Details of posts previously held and experience in any of the field of, engineering, finance, commerce, economics, law or management .
 - 2) Willingness letter to resign his/ her present post and to join UPERC, if selected.
3. The person who is considered for selection as Chairman of the Commission shall notify to the Convener of the Selection Committee:
 - (a) of the office, employment or consultancy agreement or arrangement which the person or his relative has in his own name or in any firm, association of person or body corporate, owned or otherwise controlled by any of them carrying or any of the following businesses:
 - (i) generation, transmission, distribution or supply of electricity;
 - (ii) manufacture, sale or supply of any fuel for generation of electricity;
 - (iii) manufacture, sale lease, hire or otherwise supply of or dealing in machinery, plant, equipment, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity; and
 - (iv) any entity providing any professional services to any of the business referred to in clause (i), (ii) and (iii) above.
 - (b) such other details and information as may be prescribed in the rules or by the Selection Committee.
4. A person shall be disqualified from being appointed as a Chairman of the Commission if he/she has any financial or other interest, directly or indirectly, in any private company or undertaking dealing with any of the businesses referred to in para-3(a).
5. The Chairman of the Commission shall, before taking charge of the office divest, himself/herself from the interest in all or any the business mentioned in para-3 as a condition of his/ her appointment.

6. If person to be appointed as a Chairman of the Commission holds any office under the State Government or Central Government or in any public sector corporation or Government body he/she shall submit his/her resignation or take voluntary retirement from that service and shall not seek reappointment in the service of the State Government, the Central Government, any public sector corporation or Government body at any time after he/she ceases to be Chairman of the Commission.

7. So long as the person holds the office of Chairman of the Commission and after he/she ceases to be Chariman of the Commission for any reason whatsoever, he/she shall not acquire, hold or maintain, directly or indirectly any office, employment or consultancy arrangement or businesses mentioned in para-3 and if he/she acquired any such interest involuntarily or by way of succession or testamentary disposition he/she will divest himself/herself from such interest within a period of two months of such interest being acquired.

8. The salary of the Chariperson shall be the same as that of an Election Commission of India. The Chairperson shall be entitled to Dearness Allowance and City Compensatory Allowance same as the Election Commission of India. The tenure of Chairman of the Commission shall be for a period of 5 years or till he/she attains the age of 65 years of age, which ever is earlier.
