#### Order

(Date of Public Hearing 9.9.2015)

- LPGCL submitted Rs. 16636.09 Cr. (Rs. 8.4 Cr. per MW) as provisional capital cost of 3 x 600 MW coal based thermal power plant. UPPCL submitted the verified and agreed ceiling capital cost of Rs. 16006.15 Cr. (Rs. 8.08 Cr. per MW) consented by LPGCL on 29.4.15.
- 2. Vide order dated 15.5.2015, the Commission sought following details from the petitioner:
  - i. Details of expenditure incurred in each calender year along with the source of financing viz debt and equity separately.
  - ii. Details of Loans along with the actual dates of drawls.
  - iii. Year wise calculation of IDC.
- 3. The Commission also enquired that why the start up cost of Rs. 292.99 Crore had been capitalized when as per the regulations it had to be treated as infirm power. LPGCL was directed to file data and reply on above.
- 4. LPGCL filed reply on 28.5.2015. UPPCL filed counter affidavit on 4.9.2015.
- 5. During the hearing, Sri Avadhesh Kumar Verma, Chairman, UPRVUP and Sri R.S.Awasthi made written submissions. On directions of the Commission copies were served to LPGCL and UPPCL for their reply.
- The Commission directed UPPCL to file its clear view on the issue of capital cost which is a crucial issue for the consumers of Uttar Pradesh who would be getting supply from LPGCL through State Discoms for 25 years.
- LPGCL and UPPCL were directed to file comments on above by 30<sup>th</sup> September 2015.
- 8. The next date of hearing shall be 6.10.2015 at 11:30 hrs.
