ORDER

(Date of Hearing 30th March, 2015)

- 1. Petitions were clubbed by the Commission being in the same subject of review.
- Vide order dated 04.03.2015, the Commission directed to all the parties to exchange the copies of their review applications / replies on that day itself. The parties were also directed to file their reply /counter / rejoinder to the Commission by 17.3.2015. UP Co Gen Association, Dwarikesh Sugar Industries Ltd. and Sukhbir Agro Energy Ltd. have filed replies on UPPCL's review petition. UPPCL has filed replies on objections of UP Co Gen Association and Dwarikesh Sugar Industries Ltd. during the hearing. However, no reply has been filed by UPPCL on Hindalco review petition no 1006/2015, UP Co Gen Association review petition no 1009/2015 and UP Co Gen Association petition no 1010/2015 (sec. 142).



- 3. The Commission expressed displeasure on non submission of replies by UPPCL in such important issues despite clear directions. Shri S.K. Kalia, Sr. Advocate, UPPCL, stated that due to administrative changes in UPPCL the replies could not be filed within due period and expressed regrets for the same. Shri Kalia requested Hon'ble Commission to allow three more days for filing the reply.
- 4. The Commission allowed time to UPPCL to file replies on petitions including the matter of petition no. 1010/2015 (sec. 142). The Commission further directed that in such an important matter, Director (Commercial) should be present in next hearing.
- 5. The next hearing shall be taken on 01.04.2015 at 15:00 Hrs. in the office of the Commission.
