ORDER

(Date of Public Hearing 11th August, 2015)

- RPSCL submitted that it has replied to the objections raised by the UPPCL and Consumer Organizations.
- UPPCL submitted that it has received the necessary information / documents from the RPSCL and they will submit the comments on the Expert Committee report within one month.
- 3. Mr Avadhesh Kumar Verma requested that the report of the Expert Committee should be provided to them.
- 4. Mr Ramashankar Awasthi also requested for a copy of expert committee report. He further submitted that the balance sheet and annexure to the petition of the RPSCL uploaded on website are not readable. He further requested that readable balance sheets, annexure to the petition, deficiency note and replies to the deficiency note of RPSCL may be made available to them.
- 5. The copies of the written objections by Shri A.K. Verma dated July 29, 2015 & Shri Rama Shankar Awasthi dated August 11, 2015 were served to RPSCL for their reply.



- 6. The Commission directed the UPPCL to submit its comments within the committed time period.
- 7. The Commission decided that the Expert Committee report would be made available to Shri A.K. Verma & Shri R.S. Awasthi on their request however all other relevant information submitted by the RPSCL/UPPCL or any other party and annexures/formats/copy of balance sheets etc. would be made available in the office of the Commission for examination for next fifteen days. The copies of the available information may also be obtained under the available provisions by depositing the requisite fee.
- 8. The copy of the main and supplementary reports has been provided to Shri A.K. Verma & Shri R.S. Awasthi in person / through post.
- 9. The Commission directed RPSCL to submit the replies to the deficiency note within one week of this order.
- 10. The date of next public hearing is September 15, 2015 at 12.30 A.M.
