(Date of Hearing 02.07.2014)

- 1. UPRVUNL has filed this petition for true-up of additional capitalization for FY 2011-12, provisional true up for FY 2012-13 and associated tariff components and approval of revised MYT estimates for FY 2013-14.
- 2. UPPCL opposed the petition stating that as per the Regulations, the Commission shall carry out truing up exercise alongwith the tariff petition filed for the next tariff period, with respect to the capital expenditure including additional capital expenditure incurred up to 31-3-2014.
- 3. In view of above, the Commission decided that the truing up shall be taken up with the tariff petition filed for the tariff period of FY 2014-19. UPRVUNL was directed to file the true up petition a fresh along with their MYT petition.
