ORDER

(Hearing on 04.06.2015)

Noida Power Company Ltd. has filed petition in the matter of **petition no. 987 of 2014** for denial / delay by

Uttar Pradesh Power Transmission Corporation Ltd. (UPPTCL) in handing over the physical possession of

the 220 kV R. C. Green Substation at Greater Noida to Noida Power Company Ltd. (NPCL)

The Commission finds that Noida Power Company Ltd. is a Joint Venture Company between Greater Noida

Industrial Development Authority (GNIDA) and RPG Group, and is a Distribution Licensee in the area of

Greater Noida. UPPTCL constructed 220 KV RC Green substation on the request of GNIDA on payment

basis. NPCL in turn paid total cost of this project (land cost + cost of constructed 220 KV RC Green

substation) to GNIDA.

The Commission observes that the GNIDA is a shareholder in NPCL and is responsible for the overall

development of Greater Noida area and paid the total cost of constructions of this substation to UPPTCL

and annual maintenance charges to UPPTCL. Therefore it is pertinent to seek reply of GNIDA over the

dispute between Noida Power Company Ltd. & Uttar Pradesh Power Transmission Corporation Ltd. and

others.

The Commission directs Greater Noida Industrial Development Authority U/s of 94 Electricity Act, 2003 to

submit its reply on affidavit within fifteen days on the issue of whether M/s NPCL should be handed over

the physical possession of 220 KV RC Green substation by UPPTCL or not?

Case be put up after receipt of written reply of GNIDA.
