Order

(Date of Hearing 01.07.2014)

1. The issue of transportation cost of coal for M/s Abhinav Steels Private Limited was determined by the Commission vide order dated 25.06.2012 for their coal based non-pit head Captive Generation Plant located at Sathariya which is under a Power Purchase Agreement (PPA) dated 06-05-2009 with UPPCL for supply of 10.5 MW power. The review was filed by the petitioner which was decided by the Commission vide order dated 5.11.2012 as below:

Transportation Charges of coal (₹ /Kwh)	1.04	1.10	1.16

The above coal transportation charges were to be paid by the Procurer in addition to the applicable tariff agreed in the PPA under the provisions of the Regulations.

2. Now this petition has been filed for determination of transportation cost of fuel For FY 2014-15.
3. As the Commission is in process of finalizing the Regulations which shall be applicable for FY 2014-19, it was requested by the petitioner that the transportation cost approved by the Commission for FY 2013-14 may be allowed for FY 2014-15 provisionally. UPPCL also consented the same.
4. Therefore, the Commission allows the transportation cost for FY 2014-15 as approved for 2013-14 provisionally till the new Regulations are finalized and accordingly the transportation cost is decided.
5. The petition is disposed of.
