- The Petitioner has entered into a Power Purchase Agreement (PPA) on behalf of Madhyanchal Vidyut Vitran Nigam Limited (MVVNL) with M/s Gobind Sugar Mills Ltd. on 14th day of March, 2014 for supply of 22 MW surplus power from its 30 MW Bagasse based co-generating plant situated at Khameri, Pandit, Dist. Lakhimpur Kheri.
- 2. The Petitioner has submitted that project specific changes have been incorporated in the PPA with respect to the model PPA provided with CNCE Regulations, 2009.
- 3. In the hearing, the Petitioner submitted that besides project specific changes incorporated in the PPA, no significant deviation from the model PPA has been made the commissioning of generation facility has been agreed as November 2014.
- 4. In view of above, the Commission approves the PPA.
- 5. All other terms and conditions will be as provided under existing UPERC (Captive and Non-Conventional Energy Generating Plants) Regulations.
- 6. The petition is disposed of.
