#### **ORDER**

## (DATE OF HEARING: 22.04.2025)

1. Sh. Suhael Buttan, Counsel, appearing on behalf of the Petitioner submitted that the South East U.P. Power Transmission Company Ltd. filed an instant Petition under section 86(1)(c) and (f) of the electricity act, 2003 read with Regulation 57 of the UPERC (Conduct of Business) Regulations, 2019 seeking declaration/ clarification from the Commission regarding the Transmission









Charges applicable on the Group-1 and Group-2 elements of the Project. The Prayer of the Petitioner are as follows: -

- (a) Admit the present Petition;
- (b) Hold and declare that the Petitioner is entitled to transmission charges for the Group 1 (33.947% of Quoted Transmission Charges) elements from the SCOD of the Group 1 elements, i.e., from 31.12.2014, being the first Year as per Schedule 6 of the TSA;
- (c) Hold and declare that the Petitioner is entitled to transmission charges for the Group 2A (8.377% of Quoted Transmission Charges) and Group 2B (32.513% of Quoted Transmission Charges) elements from the SCOD of the Group 2 elements, i.e., from 31.08.2015, being the first Year as per Schedule 6 of the TSA;
- (d)Hold and declare that the Petitioner is entitled to transmission charges equivalent to the last year transmission charges specified under Schedule 6 of the TSA for the Group 2 elements up to 35 years from the SCOD of the Group 2 elements, i.e., up to 15.01.2059 for Group-2A (8.377% of Quoted Transmission Charges) and up to 15.09.2060 for Group-2B (32.513% of Quoted Transmission Charges);
- (e)To pass any other order(s) as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice.
- 2. Sh. Deepak Raizada, CE appearing on behalf of the UPPCL, requested five weeks' time to file their reply. Sh. Suhael Buttan on behalf of Petitioner requested 2 weeks' time to file his rejoinder, if any.
- 3. The Commission admitted the Petition with the direction to the Respondents to file their reply within five weeks' time positively. The Petitioner may thereafter file its rejoinder, if any, within two week.

4. The matter is next listed for hearing on 08.07.2025.
