## ORDER

(DATE OF HEARING: 27.03.2025)

- 1. The Commission vide its earlier Order dated 03.03.2025 allowed NPCL and PGPPL to file their response to the intervening application of Sh. Rama Shanker Awasthi. The Commission allowed impleadment of Deshraj Solar Energy Pvt. Ltd. as a Respondent in the matter. Further, the Commission directed NPCL to furnish certain documents related to the instant Bidding process. On 25.03.2025, NPCL filed its submission. On 26.03.2025, PGPPL filed its reply to the impleadment application of Sh. Rama Shanker Awasthi. The Commission noted the change of mailing address request of the Respondent(s) vide communication dated 13.03.2025.
- 2. During the hearing today, Ms. Srishti Rai, Advocate of NPCL submitted that NPCL filed its submissions in compliance to the Commission's Order dated 03.03.2025. She further requested for adjournment of the hearing as Sr. Advocate Sh. Buddy A. Ranganadhan was indisposed due to his health complications. Ms. Iqra Khan, Advocate of PGPPL submitted that they have filed their reply to the impleadment application of Sh. Rama Shanker Awasthi. Sh.
