ORDER

(DATE OF HEARING: 13.05.2025)

- 1. The Petitioner, U. P. Rajya Vidyut Utpadan Nigam Limited (UPRVUNL), has filed instant petition for approval of provisional Capital Cost, Annual Revenue Requirement & determination of provisional Tariff in terms of the UPERC (Terms and Conditions of Generation Tariff) Regulations, 2019 for its 1X660 MW Panki Ext. Thermal Power Station.
- 2. The Petitioner has prayed the following:

- a) Admit the proposal submitted by the Petitioner for a favourable consideration as detailed in the enclosed petition, along with any clarifications submitted in this regard;
- b) Approve the provisional Capital Cost, norms for regent used in emission control system;
- c) Approve the provisional tariff with effect from the COD;
- d) Permit recovery of Statutory charges like water cess, water cost, payment to Pollution Control Board, rates and taxes, Regulatory fees, Tax on Income, Forest cess, Pay Commission revision impact, other fuel related costs, station supplies, lubricants and consumables critical to the generating stations, Gratuity and Provident fund, fees payable to UPERC/CERC/CEA/UPSLDC and any other payment made to fulfil statutory requirements on actual basis;
- e) Condone any inadvertent omissions/errors/shortcomings and permit to add/change/modify/alter/clarify this filing and make further submissions as may be required at a future date; and
- f) Permit recovery of expenses understated/ not considered in this Petition subsequent to the submission of this petition;
- g) Pass such further orders, as the Commission may deem fit and proper, keeping in view of the facts and circumstances of the case.
- 3. During the hearing, Shri Shailendra Tiwari, consultant representing the Petitioner, submitted that the instant petition has been filed for approval of provisional tariff for 660 MW Panki Ext. TPS as per the UPERC Generation Tariff Regulations 2019 and supplementary tariff of the ECS system was based on the CERC Tariff Regulations, 2024. Ms. Puja Priyadarshini, counsel for Respondents, submitted that the petitioner would be required to file a revised petition as per the UPERC Generation Tariff Regulations, 2024. Representative of the Petitioner prayed the Commission to withdraw the petition and allow to file revised petition. He also prayed before the Commission to adjust the filing fee submitted for the present petition against the revised petition as per UPERC Generation Tariff Regulations, 2024, notification dated 9th April 2025.

4. After hearing the parties, the Commission allows the Petitioner to withdraw the instant petition and directed the petitioner to file a revised petition in accordance with the UPERC Generation Tariff Regulations, 2024. The Commission also permits adjustment of the filing fee submitted for the present petition against the filing fee of the revised petition.

The petition, thus, stands disposed of as withdrawn in terms of above.
