- 1. The Petitioner(s) has filed this Petition for SCOD extension for their Small Hydro Power projects. The prayers of the Petitioner, as stated in the Petition, are as follows:
  - a) Allow the present Petition; and
  - b) Direct Respondent No. 1 and 2 to approve amendment of the PPA (Annexure No. 2) to extend the SCOD to 48 months effective from the date of order passed by this Commission in the present Petition; and / or
  - c) In the alternative, direct the Parties to arbitration for the damages arising out of the issues raised herein, and/or
  - d) Pass any other suitable order as this Commission may think to be just and proper under the facts and circumstances of the case.
- 2. During the hearing today, Advocate of Petitioner(s) sought short adjournment of the hearing as Sr. Counsel, Sh. D.D. Chopra was not available for the arguments in the
