**Public Notice**

The Distribution Licensees, viz., Dakshinanchal Vidyut Vitran Nigam Limited (DVVNL), Madhyanchal Vidyut Vitran Nigam Limited (MVVNL), Paschimanchal Vidyut Vitran Nigam Limited (PVVNL), Purvanchal Vidyut Vitran Nigam Limited (PuVVNL), Kanpur Electricity Supply Company Limited (KESCO) and Noida Power Company Limited (NPCL), Greater Noida (Referred to as Licensees) have filed the Petitions for Determination of Aggregate Revenue Requirement (ARR) / Tariff for FY 2019-20, Annual Performance Review for FY 2018-19 and True-Up for FY 2017-18 before the Uttar Pradesh Electricity Regulatory Commission (UPERC / Commission).

The Commission has admitted the same for State Distribution Companies and NPCL vide its Orders dated 01-07-2019.
