Order

(Date of Hearing 14.05.2015)

- 1. The petition has been filed by UPPCL for approval of amended Supplementary Power Purchase Agreement (SPPA) dated 30.06.2014 for purchase of surplus 7.5 MW power sourced from additional capacity of 15 MW from coal based captive power plant of M/s Abhinav Steels Pvt. Ltd. located at Vill: Satharia, Distt: Jaunpur.(U.P.) which was expected to be commissioned by August 2014.
- 2. Earlier, the respondent has first Power Purchase Agreement (PPA) dated 06.05.2009 and Supplementary PPA dated 19.07.2012 with the petitioner for 19 MW from installed capacity of 40 MW from same plant location.
- 3. During the hearing it was confirmed by the petitioner that as such there is no deviation sought in PPA from the model PPA.
- 4. The Commission approves the amended SPPA between UPPCL and M/s Abhinav Steels Pvt. Ltd dated 30.06.2104 for purchase of surplus 7.5 MW power sourced from additional capacity of 15 MW from coal based captive power plant at Vill: Satharia, Distt: Jaunpur.(U.P.). Now the total power purchase shall be 26.5 MW out of total installed capacity of 55 MW.
- 5. All other terms and conditions of PPA dated 06.05.2009 and Supplementary PPA dated 19.07.2012 and Regulations as applicable from time to time shall remain in force.
- 6. The tariff for supply of electricity from plant shall be based on weighted average of contracted capacities corresponding to their years of commissioning as provided in the Regulations.
 - Since power from newly proposed 15 MW plant is to be evacuated from the existing 132 KV transmission system, the tariff for this power will be adjusted on account of non-incurred expenditure towards the power evacuation as per Regulations and earlier orders of the Commission.
- 7. The petition is disposed of.
