ORDER

(Date of hearing 10.11.09)

The Petitioner, on behalf of U.P. Power Corporation Ltd. (UPPCL), duly authorized by Purvanchal Vidyut Vitran Nigam Ltd. (PVVNL), has entered in to Power Purchase Agreement (PPA) with M/s Abhinav Steels Private Ltd. for purchase of 10.5 MW power from captive power plant situated at Jaunpur. The copy of PPA, with projects specific modifications in model PPA, has been submitted to the Commission for approval.

The modifications made in the model PPA are as below:

1. Para 4, 5, 6 and 8 of clause 1 have been deleted.

2. Para 3 of clause 1 has been modified to incorporate authorization of UPPCL as signatory on behalf of distribution licensee.
3. Clause 2.1 has been modified in respect of power purchase rate under the provisions of CNCE Regulations, 09 with due consideration as the plant is situated at non- pit head.
4. Banking clause 2.5 has been deleted since not called for.
5. Clause 7.2 has been modified to incorporate that the coal linkage from Coal India Limited has already been obtained.
6. Clause 8.3 and 8.5 regarding construction and maintenance of the dedicated transmission line has been modified.

Dr. R. Kumar, representative of the Respondent submitted in the hearing that the coal linkage for the plant has been obtained from Ministry of Coal and coal is to be supplied from Korba coal mines of South Eastern Coalfields Limited.

The Commission approves the Power Purchase Agreement (PPA) for supply of 10.5 MW power to Purvanchal Vidyut Vitran Nigam Ltd. (PVVNL) with the above deviations. The tariff, on commissioning i.e. November, 2010, as agreed in PPA, shall be governed by prevailing CNCE Regulations, 2009.
