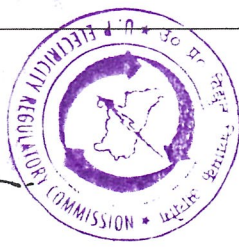

ORDER

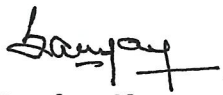
(DATE OF HEARING: 23.07.2026)

1. The present Petition has been filed wherein the Petitioner has made the following prayer:

"Exempt the Petitioner under Clause 4.46(a) of the Electricity Supply Code, 2005 and permit the Petitioner to supply the energy, supplied to the Petitioner by the Respondent and/or by licensed electricity (including renewable energy) producer/ trader, to its associate company, JBL, JVL and JACPL, situated on the same Premises;"

2. During the previous hearing on 12.05.2026, the Commission had observed that despite the directions of the Commission in its Order dated 08.04.2026, no amendment to the Petition had been filed by the Petitioner whereupon, the counsel appearing on behalf of the Petitioner had assured to file the same before the next date of hearing.
3. The Commission observes that the revised Petition, as assured by the Petitioner's counsel has yet not been filed before the Commission. The authorised representative Shri B. B. Bhatt appearing on behalf of the Petitioner submitted that their counsel was unable to appear in the matter on account of another matter listed in Hon'ble High Court and requested for one more opportunity. The Commission allows the request, while making it clear that this would be the last such opportunity granted.
4. The next date of hearing is scheduled on 22.09.2026.
