## ORDER

(DATE OF HEARING: 19.08.2025)

1. Ms. Sikha Ohri, Counsel, appearing on behalf of the Petitioners submitted that the Lalganj & Ultratech had filed the instant Petition under Regulations 20 and 21 of the UPERC (Grant of Connectivity to Intra-State Transmission System), Regulations, 2010, Regulation 38 of the Uttar Pradesh Electricity Regulatory Commission (Terms and Conditions for Open Access) Regulations, 2019 read with Regulation 57 of the Uttar Pradesh Electricity Regulatory Commission

(Conduct of Business) Regulations, 2019. The Prayers of the Petitioners are as follows: -

- (i) Admit the present Petition;
- (ii) Declare that the increase in voltage connectivity level of Petitioner No.1 from 33kV to 132kV is not a revocation/ relinquishment of the Connection Agreement dated 10.08.2022;
- (iii) Declare that the increase in quantum of power exchanged on the intra-State transmission system is not a revocation/ relinquishment of the Connection Agreement dated 10.08.2022;
- (iv) Declare that such increase in voltage connectivity level/ quantum of power exchanged on the intra-State transmission system is not a relinquishment of LTOA granted to Petitioner No.2;
- (v) Pass such other or further orders or directions as this Hon'ble Commission may deem just and proper in the facts and circumstances of the case.
- 2. After hearing the Counsel for the Petitioners, the Commission, considering it appropriate to provide an opportunity of hearing to both the parties, granted the Respondents a period of four weeks to file their reply. The Petitioners sought two weeks' time to file their rejoinder.
- 3. The Commission admits the Petition with direction to the Respondents to file their reply within four weeks' time. The Petitioners may thereafter file their rejoinder, if any, within two weeks.

4. The matter is listed for next hearing on 07.10.2025.
