ORDER

(DATE OF HEARING: 12.08.2025)

1. The Commission, vide its earlier Order dated 19.06.2025, had allowed Petitioner(s) and Sh. Awasthi to file their respective submissions within four weeks' time. On 11.08.2025, UPPCL & UPNEDA filed their respective submissions in the matter. SGEPL did not file its submissions in the matter.
2. During the hearing, Counsels of Petitioner(s) submitted that they had filed their respective affidavits on the previous day. Sh. Awasthi sought four more weeks' time to file his submissions in the matter. The Commission expressed displeasure on the delayed filing by the parties. Sh. Ruchir Ranjan Rai, Advocate of SGEPL, submitted that on the last occasion the affidavit could not be filed due to defect and requested the Commission to allow him to file his submissions within a week time else at least by end of the day. The Commission stated that even after providing several opportunities SGEPL had failed to file its response in the matter. However, the Commission accepted the request of filing by the end of the day of hearing i.e., 12.08.2025 but not before

observing that such a lackadaisical approach cannot be tolerated in the proceedings. Accordingly, the Commission closes the opportunity for the Respondent No. 2, 3, 5, & 11 for filing their responses in the matter.

3. After hearing the parties, the Commission granted four weeks to Sh. Awasthi for filing his submissions. The Commission also allows four weeks' time to the permitted project developers, i.e., other than for whom opportunity is closed by the Commission, for filing their responses to the Petitioner(s) submissions.
