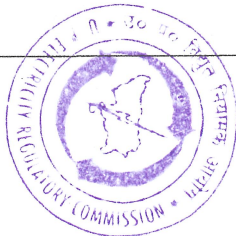

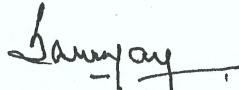




ORDER
(DATE OF HEARING: 25.09.2025)

1. The Commission, vide its earlier Order dated 11.03.2022, decided to keep the instant matter in abeyance in view of the Hon'ble High Court Judgement dated 09.02.2022 in ARB.P No. 572/2020 (IL&FS Energy Development Company Ltd. Vs. Amity University). On 23.07.2023, Petitioner filed "Application for withdrawal of Petition" in the matter.
2. During the hearing today, Sh. Aishwarya Pratap Singh, Advocate of Petitioner submitted that through "Application for withdrawal of Petition" filed on 23.07.2023, he had prayed for withdrawal of instant Petition as the parties had amicably settled all their disputes therefore, no further proceedings were further warranted in the matter. The Commission observed that none of the representative of Respondent, IEDCL were present even though the notice for hearing was issued on 28.07.2025. On specific query of the Commission regarding locus of the counsel, Sh. Singh responded that he filed his 'vakalatnama' in the matter and also his presence was marked in the Commission's Order dated 11.03.2022.
3. After hearing, the Commission allows the request of the Petitioner for withdrawal of instant Petition.

The Petition is dismissed as withdrawn.
