### ORDER

(DATE OF HEARING: 21.03.2024)

- The Petitioner (UPPCL) has filed this Review Petition seeking review of the Order, dated 16.06.2023, passed by this Commission in Petition Nos. 1527/2019 and 1931/2022 in matter of MYT and ARR for 3X210 MW Anpara A TPS for FY 2019-2020 to FY 2023-24
- 2. The Petitioner has prayed as follows:
  - (a) Allow the present Review Petition in terms of the limited grounds and submissions made hereinabove;
  - (b) Condone the delay of 35 days which has occurred in filing the accompanying Review Petition by the Petitioner, Uttar Pradesh Power Corporation Limited.
  - (c) Revise and recalculate variable charges in the impugned Order dated 16.06.2023 by considering the auxiliary energy consumption at 8.5% in terms of Regulation 26(v)(a) of the UPERC Tariff Regulations 2019.
  - (d) Pass any other further order(s) that this Hon'ble Commission may deem fit in the interest of justice.

# **Brief Facts of the Case as per Petitioner:**

3. The Petitioner has mainly submitted as under

The Commission vide the said Order has inadvertently allowed auxiliary energy consumption for Anpara A 210 MW thermal power plants at 9% and therefore, variable charges was affected. The relevant portion of the Order is being reproduced below:

# "1.7.11 Variable Charges

1.7.11.1 Based on the operation norms provided in the UPERC Generation Tariff Regulations, 2019 and the Commission's decisions in the foregoing paragraphs, the representative variable charge per unit of generation for the MYT period of FY 2014-15 to F 2018-19 is as given in the following table.

- ii. As per Regulation 26(v)(a) of the UPERC Tariff Regulations 2019, the auxiliary energy consumption should be taken at 8.5% to compute the rate of energy charges ex-bus per kWh for the tariff period FY 2019-24 for plants upto and including 200 MW series, which includes Anpara A thermal power plant.
- iii. The Respondent (UPRVUNL) itself submitted, before this Commission, the auxiliary energy consumption at 8.5% in the revised MYT and ARR Petition (No. 1931/2022) for FY 2019-20 to FY 2023-24 for Anpara A. The relevant part of the Petition is reproduced below:

iv. As per Regulation 51 of the UPERC (Conduct of Business) Regulations, 2019, the prescribed period of limitation of 90 days (from the date of the Order 16.06.2023) for filing a Review Petition before this Commission had expired on 14.09.2023. The delay of 35 days was caused due to various reasons beyond the control of the Petitioner. In view thereof, it is prayed to condone the delay of 35 days in filing the Review Petition.

# **Records of Proceedings:**

- 4. During the hearing on 19.12.2023, the Commission directed UPPCL to file an application for condonation of delay in 2 weeks. The Commission also directed UPRVUNL to file its reply on maintainability and merit in 4 weeks and UPPCL to file rejoinder in 3 weeks thereafter. UPPCL filed an application for delay condonation on 28.12.2023. UPRVUNL and UPPCL submitted reply and rejoinder dated 08.01.2024 and 12.02.2024 respectively.
- 5. The matter was again listed on 07.03.2024. The Commission directed UPRVUNL to submit the details of Boiler Feed Pumps/ Cooling Towers/ Coal Mills installed in the project and basis of claimed auxiliary power consumption in the MYT Petition within the contours of UPERC (Terms & Conditions of Generation Tariff) Regulations, 2019.
- 6. The matter was again heard on 21.03.2024. During the hearing, Counsel of UPRVUNL submitted that Anpara A TPS is a vintage plant and auxiliary power consumption in the last five years was in the range from 9.16% to 10.55%. Therefore, the Commission may reject the review sought by UPPCL.

### **UPRVUNL's Reply:**

7. On 08.01.2024, UPRVUNL filed its reply and has mainly submitted asunder:









- a) The prescribed period of limitation of 90 days for filing Review Petition, as specified in the UPERC (Conduct of business) Regulations, 2019 has already expired. A delay of 35 days in filing Review Petition may not be allowed by the Commission.
- b) Anpara A TPS is vintage plant having hereditary technical/ systemic constraints inevitably causing underperformance viz-a-viz Regulatory norms despite best efforts.
- c) Past few years' actuals performance of Auxiliary Consumption shown in table below:

- d) Auxiliary Consumption in the last five years was around 9.16% to 10.55% range based on the actual performance, which is not only higher than what is provided in Regulations, but it is also higher than what is granted in MYT Order.
- e) Therefore, the Commission may not consider the UPPCL's submission.

# **UPPCL's Rejoinder:**

- 8. On 12.02.2024, UPPCL filed its rejoinder and has mainly submitted as under:
- a) The APTEL in the Order dated 15.12.2023 in the matter of West Bengal State Electricity Transmission Company Ltd. Vs. Central Electricity Regulatory Commission & Others Appeal No.97 of 2019, condoned a delay of 53 days in filing of the Review Petition but also held that the primary function of the courts/tribunals is to do justice justice and they must endeavor to decide the matters on merit while adopting a liberal approach towards condoning the delay on sufficient cause.
- b) UPRVUNL, itself in the Petition asked the auxiliary energy consumption for 210 MW thermal power plants at the rate of 8.5%.
- c) UPRVUNL is now raising new issue and trying to gain a special allowance as per Regulation 20(4) of the Tariff Regulations 2019 as compensation for meeting requirement of expenses including Renovation and Modernization beyond the useful life,

which it failed to agitate during the original proceedings and contradicts the submissions made by them in the original proceedings.

d) As per Regulation 26(v)(a) of Tariff Regulations 2019, provides that auxiliary energy consumption should be taken at 8.5% to compute the rate of energy charges ex-bus per kWh for the tariff period FY 2019-24 for plants upto and including 200 MW series, which includes Anpara A TPS. The Commission made an inadvertent typographical error which has crept in while passing of the Order, which is the consideration of auxiliary energy consumption for 210 MW thermal power plants at 9% instead of 8.5%.

# Additional Information submitted by UPRVUNL:

9. UPRVUNL, vide affidavit dated 14.03.2024, submitted following additional information regarding Anpara-A TPS:

# Commission's Analysis and Decision:

- 10. The Commission in its Order dated 16.06.2023 in Petition No. 1527 of 2019 and 1931 of 2022 had allowed auxiliary energy consumption for 3x210 MW Anpara A TPS at the rate of 9% for the tariff period 2019-24.
- 11. Regulation 26(v)(a) of the UPERC (Terms and Conditions of Generation Tariff)
  Regulations 2019, provides as under:

# "26. Norms of operation for Thermal generating stations

Provided further that for thermal generating stations with induced draft cooling towers and where tube type coal mill is used, the norms shall be further increased by 0.5% and 0.8% respectively"

- 12. The Commission, in its Order dated 16.06.2023, worked out an auxiliary energy consumption of 9% based on the information submitted by the UPRVUNL in the MYT Petition No. 1931 of 2022, i.e. by considering additional normative auxiliary energy consumption for induced draft cooling towers, as submitted by UPRVUNL.
- 13. UPPCL, on 28.12.2023, filed its application for condonation of delay wherein it submitted that due to the nature of dispute, continuous technical assistance was required from the officials of the Review Petitioner and its financial consultants including factual and technical inputs. The Petitioner was also exploring ways to resolve this dispute amicably. Further, various documents were required to be made available from different departments, which in turn, caused a delay of 35 days in filing the accompanying Review Petition.
- 14. The Commission, though expressing its displeasure on the delayed filing of the review petition, condones the delay as sought by review applicant. It is also relevant to point out that the Commission, vide ROP for hearing dated 07.03.2024, sought clarification from UPRVUNL regarding type of Boiler Feed Pumps/ Cooling Towers/ Coal Mill installed in the Anpara A TPS. Considering the aforesaid information submitted by the UPRVUNL, the auxiliary energy consumption without cooling tower in Anpara A TPS would be 8.5%.
- 15. In view of the above, the Rate of Energy Charge ex-bus in the Order dated 16.06.2023 by considering the auxiliary energy consumption at 8.5% in terms of Regulation 26(v)(a) of the UPERC Tariff Regulations 2019 are revised as follows:
