



ORDER

(DATE OF HEARING: 29.07.2025)

1. During the hearing, Sh. Sumeet Notani, representative of RPSCL, apprised the Commission that the steering committee had decided not to issue the minutes of meeting held on 25.03.2025, since all the generators were not present. Sh. Notani further informed that steering committee had also decided to hold zone-wise meetings; however, no such meetings have been conducted yet. MS. Anjali Dhingra, counsel for UPPCL, requested the Commission to provide a longer time for listing of the matter as steering committee meetings and issuance of minutes may take considerable time.
2. The Commission decides that the matter will be considered after final decision of the steering committee on the issue of exemption from the mandatory usage of STP water.
