### **ORDER**

## (DATE OF HEARING: 22.07.2025)

- 1. The Petitioner, U.P. Rajya Vidyut Utpadan Nigam Limited (UPRVUNL), has filed this Petition seeking true-up of tariff for its Parichha Extension Stage-II (2x250 MW) Thermal Power Station for the control period FY 2019-20 to FY 2023-24 under UPERC (Terms and Conditions of Generation Tariff) Regulations, 2019.
- 2. The Petitioner has prayed the following:
  - a) The Commission is requested to Accept this Petition for true-up of additional capitalization and associated tariff components for the financial year 2019-20 to 2023-24.
  - b) The Commission is requested to Allow recovery of the additional claim generating out of the true up from the beneficiaries in line with the provision of the Regulations or in any manner that the Commission deems appropriate.
  - c) The Commission is requested to Permit recovery of expenses understated/not considered in this Petition subsequent to the submission of this Petition.

- d) The Commission is requested to Condone any inadvertent omissions /errors/short comings and permit the applicant to add/change/modify/alter this Petition and make further submissions as may be required at later stages.
- e) The Commission is requested to Pass such orders as the Commission may deem fit and proper and necessary in the facts and circumstances of the case, to grant relief to the Petition.
- 3. During the hearing, Ms. Puja Priyadarshini, counsel for the Respondent, requested the Commission for allowing six weeks' time to file its reply.
- 4. The Commission accepted the Respondent's request and allowed six weeks' time to the Respondent to file their reply and four weeks thereafter to the Petitioner for filing their rejoinder.
