ORDER

(DATE OF HEARING: 19.08.2025)

- 1. The Petitioner, U. P. Rajya Vidyut Utpadan Nigam Limited (UPRVUNL), has filed instant petition for approval of provisional Capital Cost, Annual Revenue Requirement & determination of provisional Tariff in terms of the UPERC (Terms and Conditions of Generation Tariff) Regulations, 2024 for its 2X600 MW OBRA C Thermal Power Station.
- 2. The Petitioner has prayed following:

- a) The Commission is requested to accept this submission of Multi Year Tariff of OBRA C (2x600 MW) TPS for the control period comprising FY 2024-25 to FY 2028-29.
- b) The Commission is requested to approve the Provisional Capital Cost and Annual Revenue Requirement (including Energy Charges) and determine the Provisional Tariff for the generating stations of the Petitioner for each of the financial years of the period FY 2024-25 to FY 2028-29.
- c) Permit recovery of expenses understated/ not considered in this Petition subsequent to the submission of this petition.
- d) The Commission is requested to Condone any inadvertent omissions / errors / short comings and permit the applicant to add /change /modify / alter this Petition and make further submissions as may be required at later stages.
- e) The Commission is requested to Pass such orders as the Commission may deem fit and proper and necessary in the facts and circumstances of the case, to grant relief to the Petitioner.
- 3. During the hearing, Ms. Puja Priyadarshini, counsel for Respondents, submitted that the provisional tariff for Unit -1 of Obra C had already been determined; since station has already achieved COD, therefore, at this stage the Petitioner ought to have approached for final capital cost determination. She further submitted that the Petition lacked details regarding time and cost overrun in achieving COD of the project.
- 4. Sh. Divyanshu Bhatt, counsel for Petitioner, submitted that the present petition was filed on 02.07.2025, while the COD of Unit-2 of the project happened on 09.07.2025. Therefore, the petition was filed for grant of provisional tariff based on the updated expenditure of the project thereafter, upon finalization of the audited accounts, final tariff petition would be filed along with the approval of the final capital cost. The counsel for Petitioner requested the Commission to allow Petitioner to submit the reasons for time and cost overrun and revised tariff forms vide additional affidavit.
- 5. The Commission enquired about the commissioning status of the emission control system to which the representative of Petitioner replied that although certain

expenditure has been incurred towards the system and has been included in the updated expenditure of the project for the purpose of provisional tariff, the system was likely to be commissioned by the year end only.

6. The Commission observes that the provisional tariff was determined only for Unit -1 of Obra C, however, the instant petition has been filed for the determination of provisional tariff for the Project i.e., both Unit -1 and Unit -2 of Obra C combined. The Commission accepts the Petitioner's request and allows four weeks to submit required information and revised tariff forms through an additional affidavit. The Commission also directs the Petitioner to submit (i) revised Auditor Certificate (s) for the Project Cost excluding the expenditure of emission control system (ii) expenditure for emission control system.
