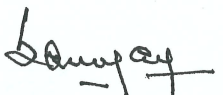

**ORDER**  
**(DATE OF HEARING: 04.11.2025)**

1. The Commission vide its Order dated 26.09.2025 admitted the Petition and allowed NREL to file its reply within two weeks' time, if any. Further, the Commissions directed UPPCL to furnish certain information regarding bidding process within two weeks' time. Respondent has still not filed its reply in the matter.
2. During the hearing today, Sh. Divyanshu Bhatt, Counsel of UPPCL submitted that on the previous day, an additional submission in the matter had been filed in compliance to the Commission's Order dated 26.09.2025 while apologising for the delayed filing. The Commission expressed its displeasure towards UPPCL's lackadaisical approach and cautioned the Counsel of UPPCL for its delayed submissions. The Commission advised UPPCL/parties to file respective submissions at least 5 working days before the next hearing date. Therefore, the Commission adjourned the hearing as it was not possible to go through the documents filed by UPPCL just on the previous day.
